## MuBANY Mentorship Program

Recognizing the importance of mentorship, MuBANY pairs up law students and junior attorneys with mid-level and senior attorneys. MuBANY kicked off this year's program in November 2010 and featured a follow up networker this spring. Let us know if you would like a mentor or mentee!

## MuBANY Partners with Area Bar Groups

Through programming and partnerships, we have built important relationships with peer bar associations. We are members of the local Network of Bar Leaders and the statewide Conference of Bar Leaders. We co-organize professional development and educational programs with groups like NYCLA, NYSBA, and SABANY.

### MuBANY Advocacy

In addition to serving members, MuBANY has been a vocal advocate on behalf of Muslim Americans on a local and national level. Our work has included:

- Co-drafting "CountertERRORism Policy: MACLC's Critique of the NYPD's Report on Homegrown Radicalism," with the Muslim American Civil Liberties Coalition (MACLC)
- Organizing a press conference regarding NYPD screening of "The Third Jihad," with MACLC
- Media appearances, letters, and op-ed submissions regarding Muslim attorneys, the civil rights of Muslim Americans, etc. (New York Law Journal, CBS2TV, Crain's Business NY, KSA2TV, WNYC)
- Drafting a letter to U.S. Senate Committee on the Judiciary Committee Regarding Violations of Privacy Faced by Americans Returning from Overseas Travel, with community partners
- Drafting a letter to U.S. Senate Foreign Relations Committee Regarding Hearing on Engaging with Muslim Communities Around the World, with community partners
- Co-signing a letter to U.S. House Leadership regarding the 2011 Peter King hearings, with community partners
- Co-signing a letter to President Obama on Protecting Zakat, with community partners
- Co-signing an amicus brief in Northwest Austin Municipal Utility District Number One v. Holder (United States Supreme Court)
- Co-signing an amicus brief in *Samadov v. U.S. Attorney General* (Third Circuit Court of Appeals)
- Issuing joint statements on international issues, including events in Pakistan, Palestine and Sudan.
